



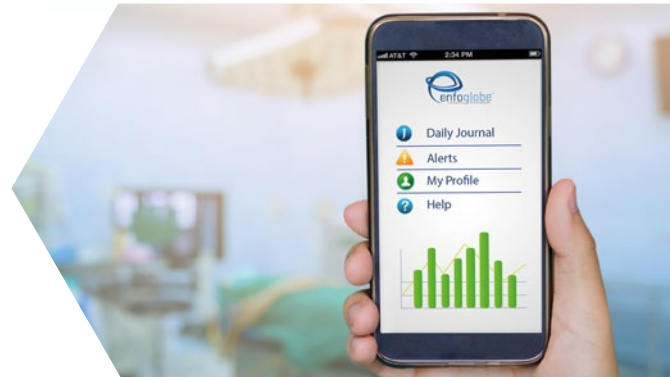
INTERACTIVECARE

Interactive Care™ is a secure online system that educates patients about risks involved in medical procedures and tracks patient health status after and during treatment. **Media-rich forms with interactive videos, animations and 3D graphics illustrate procedures and complications that may arise.** Patient mobile application is used to track daily progress questions and send information to the doctor. Built-in analytics graph progress detail on the mobile device and at doctor's portal.



THE PATIENT PORTAL

Patient portal provides reminders, multimedia education and quizzes after each module as well as tracking of progress and digital consent by the patient for the procedure. Traditional paper- based IC forms are long and detailed and use medical jargon that most patients do not understand. Patients often sign forms without carefully reading them.




DOCTOR'S PORTAL

Doctor's and administrative portal shows quiz and educational progress across all patients plus advanced analytics, graphs of health progress based on data collected from patient mobile app. Doctor's portal collects patient health progress as registered by patient on mobile devices. Answers to daily questions about progress are converted to graphical representations.

FEATURES:

- ICMobile app connects with doctor portal to synchronize and send back information.
- Patients learn using interactive videos, diagrams, animations, and 3D graphics
- Patients and doctors, nurses use Chat and Video to clarify any doubts
- Doctor and nurse portal shows patient progress analytics and graphs across patients for various timelines. It supports research based on patient data
- Quizzes at the end of every module measure the patient's understanding and reinforce information
- Explanation of incorrect answers are provided to the patient
- Patient portal for easy access, education, consent certification, and communication
- Doctor, Admin portals for progress monitoring, communication, customizing education content, analytics
- Alerts for doctors about poor quiz results or incomplete progress
- Alerts for Patients about upcoming treatments and online portal
- Highly secure access and management of patient data
- Timeline views of events scheduled for patient
- Electronic signature page at the end of training; used for certification or informed consent

ADVANTAGES:

GREATER PATIENT SATISFACTION

Patients have significantly higher satisfaction with the interactive, computer-based interactive IC process. Such satisfaction may translate into higher satisfaction with the doctor or clinic. Patients satisfied with their clinic are least likely to initiate a law suit.

BETTER UNDERSTANDING

Computer-based visualization of medical procedure significantly improves patients' knowledge and comprehension of the medical procedure and the related risks.

LESS ANXIETY AND GREATER SATISFACTION

Multiple studies show that patients feel less anxious when using interactive informed consent, because information is simpler and less overwhelming.

TEST RESULTS TO CONFIRM UNDERSTANDING

Testing patient's understanding after each major procedure segment assesses level of understanding and can trigger follow-up actions.

COMMUNICATION WITH MEDICAL STAFF

Chat and Video sessions allow posting questions to medical staff. Direct interaction builds a better relationship with patient.

CUT PAPER COSTS

Online system reduces paper and storage costs dramatically. Signed electronic documents are securely stored online. New modules and quizzes can be added using built-in tools.

INTEGRATION WITH EXISTING ELECTRONIC HEALTH RECORDS

This online platform can be integrated with existing systems.

ACCESS ANYWHERE

Patient portal provides access anywhere at any time through the Internet using tablets or other mobile devices. InteractiveCare kiosks can be set up right in the doctor's office.
